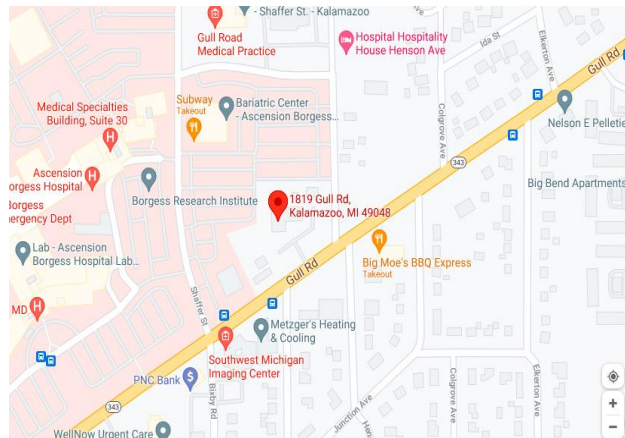

## IAP SERVICES

Consultation Fees are due at the time of the consultation. Service Fees are due at the time of finalizing the applications or petitions for submission to USCIS. Applications will not be released to the client nor mailed to USCIS under any circumstances if the services fees have not been paid in full. Service Fees can be paid by credit card, cash or money order.

### FEE POLICIES

All prices listed are for those falling under the 200% of poverty level for their household. An additional service fee of \$50 will be added for households falling between 200% and 400% of the federal poverty level for all services except those listed under Initial Services. A waiver of all or part of a service fee may be available at the discretion of the Program Director. Clients must provide their most recent tax return and current paystubs to receive the

listed prices. If unwilling or unable to verify income, clients will be assessed the \$50 service fee on top of the listed prices.

## HOW TO BE A CLIENT OF IAP

The Immigration Assistance Program accepts new clients only after an initial consultation. Initial consultations are held on Mondays at our office located at 1819 Gull Rd, Kalamazoo, near Ascension Borgess Hospital. The appointments are on a walk-in basis between the hours of 9am and 4pm. If it is determined by the IAP that there is a manner in which we can help the prospective client, we will provide that person with a list of documents required for the submission of their application/petition and an appointment for follow-up.

It is important that when you attend your initial consultation, that you bring all correspondence that you received from US Citizenship & Immigration Services or the National Visa Center and copies of all documents that have been submitted to either of those agencies. You must also bring your most recent tax return to verify income.

The adult for whom the immigration benefit is being sought should attend the initial consultation with the Petitioner (i.e. if you want to file for your spouse, both you and your spouse need to attend the consultation).

## STATEMENT AGAINST FRAUD

Remember that all the appointments will be in the office during regular business hours. Someone from our office will never go to your house or any other place outside the office. You will always get a receipt at the time of payment and the receipt from the government less than a month after sending an application to immigration.
